






#### PROJECT NEED

- > Current Comprehensive Conservation Management Plan (CCMP): 1995
- > Current Comprehensive Habitat Management Plan (CHMP): 2006
- > Changes in the Basin over the last 30 years:
  - Demographics
  - Water quality
  - Habitat restoration
  - Flood management
  - Environmental justice factors
  - Climate Change
- Approach to revising the CCMP will be inclusive, relevant, and forward-looking

#### **APPROACH**

- Build a framework for analysis, dialogue, and consensus building
- Engagement at relevant stages
   with: Executive Committee,
   Management Conference, regional
   leaders, and other key stakeholders
- Consistent with EPA's Goal 5 (Ensure Clean and Safe Water for All Communities)



#### TASK 1. ESTABLISH THE FRAMEWORK FOR PREPARING A REVISED CCMP

- Review scope, goals, objectives, and priorities of 1995 CCMP and determine need for revisions
- Identify priority issues
- Establish work groups

#### TASK 2. DEVELOP PRIORITY ISSUES REPORT

- Develop reports for priority issues
  - Uses existing data
  - Includes status and trends
  - Includes assessment of causal mechanisms and consequences of changes
  - Includes updated Comprehensive Habitat Management Plan (CHMP)

### TASK 3. IDENTIFY, EVALUATE, AND PRIORITIZE ACTIONS AND DEVELOP ACTION PLANS

- Inventory actions to address priority issues
- Develop action plans
  - Describe proposed actions
  - Identify responsible parties
  - Include status updates
  - Include cost estimates and constraints
- Document changes from previous CCMP

#### TASK 4. DEVELOP SUPPORTING STRATEGIES & MONITORING PLAN

- Develop strategies for habitat protection/restoration based on the updated CHMP
- > Develop strategies for communication and outreach
- Develop monitoring plan to determine effectiveness of CCMP

#### TASK 5. DEVELOP REVISED CCMP

- Develop draft and final CCMP
  - Determine content with stakeholders and Management Conference
  - Synthesize methods, conclusions, and recommendations from all tasks

#### TASK 6. OUTREACH & ENGAGEMENT

- Identify key audiences
- Develop strategies for delivering messages
- Develop print and digital outreach materials
