a. WQX Status

Our current USer Support Period of Performance is coming to an annual close, so we're starting to wrap up Helpdesk Support for this season.

Continue working with the Node helpdesk on updating ENSC service changes, requesting WQX services registered for the DEVELOPMENT then PRODUCTION environment.

The Exchange Network Services Center (ENSC) is a web-based tool designed to allow Exchange Network users to easily send, get, and download information from other partners on the network.

There was a recent quick release at the end of May. Working toward another quick release to align with the end of the support contract slated for the end of July.



c. WQX Helpdesk report (Shav)

- i. Just shy of 70 user inquiries since last month. Mostly consisting of:
 - 1. 23% Domain characteristic, taxon, and analytical method requests
 - 2. 13% Data inquiries/assistance
 - 3. 28% WQX User Account Requests
- ii. Average time for first response to a request being between 1-2 hours with most tickets being resolved within 24 hours.
- iii. Working on documentation for new users to WQX Web. Documentation on getting registered to WQX Web, importing data. Looking for feedback on materials from others.

You can find the delete data options under the same Import a File link on the WQXWeb application home screen.



From there you will find not only the data import and update options, but also options for deleting data of different types.



Clicking one of these options will prompt you to upload your deletion file:



Note: Keep in mind the required primary indicator for storing data in WQX. Deleting Project or Location IDs will also delete the underlying Activities and Results if they are not associated with other IDs in the system.

The format is a simple 1 column spreadsheet file of the IDs you want to delete from the system.


What is "1 on 1" data assistance?



3. Open Discussion/ Other/Wrap-up

Question from Thomas D. - Will the former profiles be available in the WQX beta? - Yes, but only for at least 18 months and it is likely that they will need to be transitioned over sometime during that 18 month period.

Question from Chris N. - Is there a way to document blank correction factors in WQX? They will be submitting data for low-level PCB congeners and would like to document the blank correction factor. Wondering if others may have had similar experiences? - There may be a creative way to report those values in WQX. May want to add a new characteristic for the corrected values and include blank correction factor as a comment? Suggest reviewing the Activity Type options that may include measurements reported as blank corrected values. If you do not see an Activity Type that properly captures what you want to report, then ask the Helpdesk to register a new one with the definition you want provided.
