III.B. Contractors (change applicable to Tribal applicants only)		If a Tribe procures goods or services that will be paid for with EPA funding awarded on or after October 1, 2024, they will no longer be required to follow the competition requirements in 2 CFR Part 200 and instead may follow the same competitive policies and procedures they use for procurements from non-Federal funds. Note, however, that are still subject to EPA's Disadvantaged Business Rule at 40 CFR § 33.304 when conducting procurements.
III.C. Cost Sharing and Matching Requirements		As provided in 2 CFR § 200.1, cost sharing or matching means the portion of project costs not paid by Federal funds or contributions. Consistent with the authorizing statute in CERCLA § 104(k)(7) (for Assessment and Multipurpose)/the Bipartisan Infrastructure Law (for Cleanup and RLF), cost sharing and matching funds are not required under this competition. As provided in 2 CFR § 200.1, Voluntary committed cost sharing is when an applicant voluntarily proposes to legally commit to provide costs or contributions to support the project when a cost share is not required. Voluntary cost share will not be accepted under this competition.
