Circuit Rule 15, the American Coke and Coal Chemicals Institute (ACCCI) and the Coke Oven Environmental Task Force (COETF) hereby petition this Court for review of the U.S. Environmental Protection Agency's final agency action entitled "National Emission Standards for Hazardous Air Pollutants for Coke Ovens: Pushing, Quenching, and Battery Stacks, and Coke Oven Batteries;

Residual Risk and Technology Review, and Periodic Technology Review," 89 Fed. Reg. 55684-55757 (July 5, 2024).
