The U.S. Environmental Protection Agency, Region 5, is providing notice of its intent to issue an Administrative Order on Consent (AOC) to Archer-Daniels-Midland Company (ADM) under the authority of Section 1423(c)(1) of the Safe Drinking Water Act (SDWA), 42 U.S.C. §300h-2(c).

The AOC addresses only EPA's allegations contained therein that ADM failed to comply with the SDWA, 42 U.S.C. §300h-2, requirements of its Underground Injection Control (UIC) Permit No. IL-115-6A-0001 (Permit), and the UIC regulations at Title 40 of the Code of Federal Regulations Part 144 and Part 146 at its Class VI injection well facility in Decatur, Macon County, Illinois (Well). Specifically, EPA alleges in the AOC that there was movement of fluid from the Mount Simon formation injection zone – located at depths between 5,553 feet and 7,043 feet below ground surface – to the shallower Ironton-Galesville formation due to holes in in the sample tubing in one of ADM's monitoring wells. This is an alleged violation because ADM constructed, operated, maintained, plugged, or conducted injection activity in a manner that allowed the movement of injection and formation fluids into an unauthorized zone. EPA also alleges that ADM failed to monitor the Well in accordance with the Permit.

The AOC requires that ADM implement compliance measures at its Well. Pursuant to the compliance plan, ADM must implement certain provisions of the Permit's Emergency and Remedial Response Plan for a monitoring well integrity failure including identifying and implementing appropriate remedial actions, submit a status report, conduct an evaluation of the extent of fluid migration, identify if any wells require corrective action due to the migrated fluid and conduct this corrective action, and submit any necessary permit applications.
